AMENDMENT TO BYLAWS OF CYPRESS COVE MANAGEMENT ASSOCIATION, INC.

The following amendment(s) is/are made to Article XXII, Section 22.2 of the BYLAWS OF CYPRESS COVE MANAGEMENT ASSOCIATION, INC., recorded in Official Records Book 866, Page 943, et. seq., of the Public Records of Lake County, Florida (additions are indicated by underlining, deletions are indicated by strikethrough, and omitted but unaltered provisions are indicated by ellipses):

ARTICLE XXII. AMENDMENTS

Amendments to these bylaws shall be proposed and adopted in the following manner:

An amendment may be proposed either by a majority of the board of directors or by not less than one-third (1/3) of the members of the association. The amendment shall be adopted if it is approved either by: (a) not less than a majority of the votes of the entire membership of the association (e.g., once a quorum of members attending in person or by proxy has been obtained at an annual or special meeting of the members of the Association, a majority of all unit owners [i.e., 50% plus 1 of all unit owners] may amend these Bylaws), and by not less than two-thirds (2/3) of the board of directors; or (b) by not less than 75% of the votes of the entire membership of the association.
